Marine Corps Base Quantico, Virginia - Commonly abbreviated MCB Quantico, Marine Corps Base Quantico is a United States Marine Corps installation located near Triangle, Virginia, covering nearly 86.169 square miles) of southern Prince William County, Virginia, northern Stafford County, and southeastern Fauquier County / Used primarily for training purposes, MCB Quantico is known as the "Crossroads of the Marine Corps" / In 1917, Marine Barracks, Quantico was established and thousands of Marines were trained at Quantico during World War I / In 1934, Amphibious Warfare Doctrine, along with special amphibious landing crafts for World War II were developed at Quantico / These Amphibious Warfare techniques, developed in the years before World War II, made victory possible in the Pacific theater / Quantico trained over 15,000 USMC and other service officers in Amphibious Warfare techniques / The first Marine Aircraft Wing was developed at Quantico, as well as the Corps' first helicopter squadron, Marine Helicopter Squadron One (HMX-1), the first helicopter squadron to provide rapid transportation for Presidents of the United States ("Marine One")

Donald MacLeod was Honorably Discharged from the US Navy on 20 July 1973 / Donald J. MacLeod passed away on 26 February 2021

USS Laffey (DD-724) is an Allen M. Sumner-class destroyer, which was constructed during World War II, laid down and launched in 1943, and commissioned in February 1944 / Laffey was the second ship of the United States Navy to be named for Bartlett Laffey / Seaman Laffey was awarded the Medal of Honor for his stand against Confederate forces on 5 March 1864 / The ship earned the nickname "The Ship That Would Not Die" for her exploits during the D-Day invasion and the battle of Okinawa when she successfully withstood a determined assault by conventional bombers and the most unrelenting kamikaze air attack in history / In mid January 1952, she sailed for Korea and took part in the blockade of Wonsan in Korea / The USS Laffey was decommissioned on 9 March 1975 / Laffey received the Presidential Unit Citation and five battle stars for World War II service, the Korean Presidential Unit Citation and two battle stars for Korean War service, the Meritorious Unit Commendation during the Cold War, and the Battle "E" during all three conflicts / Laffey was declared a National Historic Landmark in 1986, at which time she was recognized as the only remaining US-owned Sumner-class destroyer, and for her spirited survival of the kamikaze attack / Today, Laffey is a U.S. National Historic Landmark and is preserved as a museum ship at Patriots Point, outside Charleston, South Carolina



Staff Sergeant Thomas R. Mahlmeister was part of his unit's Honor Guard at the funeral of Astronaut Gus Grissom who perished when his Apollo 1 Command Module interior caught fire and burned on January 27, 1967 during a pre-launch test

Base Assignments:

Lackland AFB, San Antonia, Texas - Construction on Lackland Air Force Base began on 15 June 1941, and it was originally part of Kelly Field / On 3 Feb 1948, the facility was named Lackland AFB after Brigadier General Frank Lackland, who was commissioned into the regular Army after serving in the National Guard, District of Columbia / Lackland is best known for its role in being the sole location for U.S. Air Force enlisted Basic Military Training (BMT) for the active duty Regular Air Force, Air Force Reserve and Air National Guard

Stewart Air Force Base, Newburgh, New York - Stewart AFB is named after Captain Lachlan Stewart, a 19th Scotish-born sea captain who skippered schooners and other sailing vessels around 1850-1870 / During World War II the City of Newburgh turned the airport over to the United States Government for the purposes of training West Point cadets to fly / The field grew and at the end of World War II it became Stewart Air Force Base / Stewart was used for North American Air Defense (Headquarters US Army Air Defense Command Region I) until 1972, when the Air Force determined that the base was excess, and deeded Stewart Air Force Base to the State of New York

Tan Son Nhut Air Base, Saigon, Vietnam - Located near the city of Saigon in southern Vietnam, the French Colonial government of Indochina constructed a small unpaved airport in the 1920s, known as Tan Son Nhat

Airfield / During the Vietnam War (1959-1975), Tan Son Nhut was a major United States base for Army, Air Force, Navy, and Marine units / As the headquarters for the South Vietnamese Air Force, Tan Son Nhut was primarily a command base, with most operational units using nearby Bien Hoa Air Base

Thomas R. Mahlmeister graduated from Seneca Vocational High School and worked for AT&T prior to entering the military / After his Honorable Discharge, Mahlmeister went to work for Moog where he was employed as a technician in the Aerospace Department until his retirement / Thomas R. Mahlmeister passed away in 2017 and is interred in the Field of Valor within St. Matthew's Cemetery, West Seneca, New York

Fellow Apollo 1 astronauts Senior Pilot Ed White, who had flown in space on the Gemini 4 mission when he became the first American to make a spacewalk, and Pilot Roger B. Chaffee were also lost in the module fire on January 27, 1967 / Grissom's funeral services and burial at Arlington National Cemetery were held on January 31, 1967 / Dignitaries in attendance included President Lyndon B. Johnson, members of the U.S. Congress, and fellow NASA astronauts

Activated in 1954 at Griffiss AFB, New York, the mission of the Defense Systems Evaluation Squadron was to provide Electronic Counter-Measure (ECM) training and evaluation services to the various Aircraft Control and Warning Squadrons / The squadron was initially assigned TB-29 Superfortresses, and some TB-25 Mitchells / The B-29s and B-25s contained an assortment of Radar jamming devices to provide the required ECM and a C-47 was used as a support aircraft to ferry personnel and equipment / During the period that the 4713th operated these aircraft, they provided the operators radar squadrons with thousands of hours of ECM training / Effective 8 July 1958, the ADC re-designated the unit as the 4713th Radar Evaluation Squadron (ECM) / In the early years of the 1960's, the squadron was moved to Stewart AFB, New York and operated until 1974 when the squadron was inactivated

Ronald Malone was a member of Moose Lodge 2163 and Frontiersmen Veterans of Foreign Wars, VFW Post 7545 / Ronald Malone passed away on 3 August 2023 at the age of 74 years old

The 58th deployed to Vietnam in February 1968 / Scout dogs were trained for jungle combat in a twelve week course that started with obedience and then taught voice and body signals / The German Shepherd Dog (GSD, also known as Alsatian) was the most common service dog in the Vietnam War, used for scouting, sentry duty, mine/tunnel detection, and water patrols / Labrador retrievers were also widely used, primarily as trackers / Dogs were trained to alert their handlers to all kinds of hidden dangers, from snipers to trip wires and weapons caches / Dogs could even detect enemy fighters submerged in rivers, breathing through hollow reeds and waiting to attack American watercraft / These dogs and their handlers are credited with saving more than 10,000 U.S. lives and preventing certain injury for countless more / The dogs were so effective that they became special targets for the enemy, who began attacking kennels and offering bounties for the shoulder patch of a dog handler or the tattooed ear of a service dog

The Purple Heart was instituted in 1782 by George Washington and is the first and oldest military American decoration / The Purple Heart is awarded to military service members wounded or killed in action, in the latter case posthumously

James B. Maloney was Honorably Discharged from the United States Navy on 8 May 1968 / James Maloney was a member and Past Commander of the Matthew Glab American Legion Post #1477 / James B. Maloney passed away on 14 August 2019

USS Mispillion (AO-105) was an Ashtabula-class oiler[1] that served in the United States Navy from 1945 to 1974 / She was then transferred to the Military Sealift Command to continue in non-commissioned service as United States Naval Ship USNS Mispillion (T-AO-105), in which capacity she served until 1994 / Commissioned on 29 December 1945, the Mispillion has been the only U.S. Navy ship to bear the name / Between 1946 and 1950, she alternated on station tanker duty between Tsingtao, China; Shanghai, China; Subic Bay, Philippines; and Eniwetok, with shuttle runs between the oil port of Bahrain in the Persian Gulf and various ports in Japan, China, the Philippines, the Marshall Islands, and the Mariana Islands / With the outbreak of the Korean War, Mispillion joined Task Force 90 / During her first combat tour she provided logistic support for the huge invasion force that landed United Nations forces at Inchon on 15 September 1950, then rounded the Korean Peninsula to support the forces operating in the Wonsan area / She continued to support United Nations naval forces as they enforced a continuous blockade of the North Korean coast, rendered gunfire support to United Nations ground

forces, and bombarded Communist supply areas, troop concentrations, and transportation centers / Operating in both the Yellow Sea and the Sea of Japan, Mispillion also supported the aircraft carriers of Task Force 77, providing aviation gasoline and fuel oil for the ships / In April 1967 Mispillion got underway for her first Western Pacific deployment since 1964 / Arriving at Subic Bay, Philippine Islands, on 22 April 1967, she began a seven-month cruise refueling aircraft carriers and gunfire support ships of the Seventh Fleet operating in the Vietnam area during the Vietnam War / Servicing in particular the ships of Yankee Station, she transferred over 71 million US gallons of fuel before returning to Long Beach on 30 November 1967 / Cruising United States West Coast and Hawaiian waters for the next five months, she conducted coastal operations and exercises in preparation for departing on 11 May 1968 to serve with the Seventh Fleet through the remainder of 1968 / Mispillion was decommissioned on 26 July 1974 and transferred to the Military Sealift Command, where she continued in non-commissioned U.S. Navy service with a civilian crew as United States Naval Ship USNS Mispillion (T-AO-105) / She was struck from the Naval Register on 15 February 1995 and moved to Brownsville, Texas for scrap/ The USS Mispillion was the last World War II-built oiler in existence



The 98th Infantry Division ("Iroquois") was a unit of the United States Army in the closing months of World War I and during World War II / The unit is now one of the U.S. Army Reserve's training divisions, officially known as the 98th Training Division / The 98th Training Division's current primary mission is to conduct Initial Entry Training (IET) for new soldiers / It is one of three training divisions subordinate to the 108th Training Command (IET) / The 98th Division was activated at Camp McClellan, Alabama in October 1918, too late to see service in World War I / The 98th was ordered into active military service on 15 September 1942 at Camp Breckinridge, Kentucky, filling its ranks primarily with soldiers from New York and New England / The 98th spent the next eighteen months training at Camp Breckinridge, Kentucky, Camp Forrest, Tennessee and Camp Rucker, Alabama in anticipation of combat in the Pacific theater / Arriving in Oahu, Hawaii on 19 April 1944, the roughly 19,590 soldiers of the 98th relieved the 33rd Infantry Division of responsibility for the defense of the Hawaiian Islands and continued training for deployment to Asia / The 98th Infantry Division arrived in Japan on 27 September 1945 and served in Osaka, Japan as part of the occupying force until 16 February 1946 / In fall 2004, the 98th Division arrived in Baghdad and filled the ranks of the Multinational Security Transition Command-Irag (MNSTC-I), the unit charged with assisting the Iraqi government in developing, training and equipping the new Iraqi security forces / Five 98th Training Division soldiers were killed in action during the division's deployment to Iraq in 2004–05 / The division also fielded soldiers to such other locations as Guantanamo Bay, Cuba, the Horn of Africa, Kuwait, Jordan and Afghanistan

Lackland AFB, San Antonio, Texas - Construction on Lackland Air Force Base began on 15 June 1941, and was originally part of Kelly Field / On 3 Feb 1948, the facility was named Lackland AFB after Brigadier General Frank Lackland, who was commissioned into the regular Army after serving in the National Guard, District of Columbia / Lackland is best known for its role in being the sole location for U.S. Air Force enlisted Basic Military Training (BMT) for the active duty Regular Air Force, Air Force Reserve and Air National Guard

Sheppard AFB, Texas - The base, located near Witchita Falls, was is named in honor of Senator John Morris Sheppard of Texas (1875–1941), chairman of the Senate Military Affairs Committee from 1933 until his death on 9 April 1941. Senator Sheppard helped lead the fight for military preparedness before the attack on Pearl Harbor / It was officially opened as a United States Army Air Corps training center on 17 October 1941, following the arrival of the first military members on 14 June. As the Army Air Corps became the Army Air Forces, facilities were completed sufficiently to allow the first class of 22 aviation mechanics to enter training that October; the class graduated 23 February 1942 / Sheppard Field reached its peak strength of 46,340 people while serving as a

separation center for troops being discharged following World War II from September through November 1945 / Communications, refrigeration, air conditioning, and power production operator and repairman training were transferred to Sheppard in 1959

Wright-Patterson AFB, Dayton, Ohio - The base began with the establishment of Wilbur Wright Field in May 1917 / Wright-Patterson AFB was established in 1948 as a merger of Patterson and Wright Fields / The base is one of the largest, most diverse, and organizationally complex bases in the Air Force with a long history of flight tests spanning from the Wright Brothers into the Space Age / Wright-Patterson is also the headquarters of the Aeronautical Systems Center and the Air Force Research Laboratory

Tan Son Nhut Air Base, Saigon, Vietnam - Located near the city of Saigon in southern Vietnam, the French Colonial government of Indochina constructed a small unpaved airport in the 1920s, known as Tan Son Nhat Airfield / During the Vietnam War (1959-1975), Tan Son Nhut was a major United States base for Army, Air Force, Navy, and Marine units / As the headquarters for the South Vietnamese Air Force, Tan Son Nhut was primarily a command base, with most operational units using nearby Bien Hoa Air Base

Offutt AFB, Omaha, Nebraska - The base was named to honor First Lieutenant Jarvis Jennes Offutt (26 October 1894 – 13 August 1918), the first native of Omaha to become a casualty in World War I / Lieutenant Offutt died of injuries sustained when his SE-5 fighter crashed during a training flight near Valheureux, France / In November 1948, Offutt became the host base for Headquarters Strategic Air Command (SAC) / During the Cold War, a general and various support personnel from the base were airborne 24-hours a day on an EC-135 from February 1961 to July 1990 in Operation Looking Glass, creating an airborne command post in case of war / Operation Looking Glass carried out its mission without any mishaps or incidents during its 29 years of existence / Offutt AFB's legacy includes the construction of the first two bombers to drop atomic bombs and over 40 years as the headquarters for the former Strategic Air Command (SAC) and home for its associated ground and aerial command centers for the U.S. in case of nuclear war during the Cold War

James Manley graduated from Kenmore East Senior High School in 1966 / Prior to joining the U. S. 

Eisenhower, who had been the Supreme Headquarters Allied Expeditionary Force Commander during World War II / Because of the legal status of West Berlin as an occupied territory, the Army of Occupation Medal was issued for forty-five years until the unification of Germany in 1990, making it one of the longest active military awards of both the Second World War and the Cold War / To be awarded the Army of Occupation Medal, a service member was required to have performed at least thirty consecutive days of military duty within a designated geographical area of military occupation



Light Weapons Infantryman lack heavy weapons and armor or with a reduced vehicle footprint / Light infantry units lack the greater firepower, operational mobility and protection of mechanized or armored units, but possess greater tactical mobility and the ability to execute missions in severely restrictive terrain and in areas where weather makes vehicular mobility difficult / Light infantry forces typically rely on their ability to operate under restrictive conditions, surprise, violence of action, training, stealth, field craft, and fitness levels of the individual soldiers to compensate for their reduced lethality / Despite the usage of the term "light", forces in a light unit must carry everything they require to fight, survive and win due to lack of vehicles



The Air Defense Artillery Branch is the branch of the United States Army that specializes in anti-aircraft weapons (such as surface to air missiles) / In the U.S. Army, these groups are composed of mainly air defense systems such as the Patriot Missile System, Terminal High Altitude Area Defense (THAAD), and the Avenger Air Defense system which fires the FIM-92 Stinger missile / The Air Defense Artillery branch descended from Anti-Aircraft Artillery (part of the U.S. Army Coast Artillery Corps until 1950, then part of the Artillery Branch) into a separate branch on 20 June 1968 / The mission of Air Defense Artillery is to protect the force and selected geopolitical assets from aerial attack, missile attack, and surveillance

Army and the U.S. Marine Corps are the only military services that award marksmanship qualification badges / The U.S. military marksmanship qualification badges are awarded in three grades (highest to lowest): expert, sharpshooter, and marksman while their marksmanship competition badges are awarded in three to four grades (highest to lowest): distinguished, silver, and bronze for the U.S. Army and distinguished, gold, silver, and bronze for the Marine Corps

The Good Conduct Medal is one of the oldest military awards of the United States Armed Forces / The U.S. Navy's variant of the Good Conduct Medal was established in 1869, the Marine Corps version in 1896, the Coast Guard version in 1923, the Army version in 1941, and the Air Force version in 1963 / The Good Conduct Medal is awarded to any active duty enlisted member of the United States military who completes three consecutive years of "honorable and faithful service" / Such service implies that a standard enlistment was completed without any non-judicial punishment, disciplinary infractions, or court martial offenses

Michael N. Murphy attended college prior to military service earning a Bachelor of Science Degree in Economics / Michael Murphy was a member of Veterans of Foreign Wars, VFW Post 2940

The 16th Combat Aviation Group was formed in Battle on 23 January 1968 and thus it's motto "Born In Battle" / The Group was activated at Marble Mountain, Da Nang in I Corps / The 16th Aviation Group was awarded the Valorous Unit Award for their actions on 11 to 31 August 1969 / 23rd Infantry Division (AMERICAL) was reactivated on 25 September 1967 / The Military Assistance Command, Vietnam (MACV) preferred the name AMERICAL, listed it as such in numerous official orders, called it "the Army's only named division on active service," and used the vehicle bumper abbreviation AMCAL / In Vietnam the rugged terrain of southern I Corps tactical zone was used by the division for its encampment at Chu Lai / This ran the gamut from marshy, coastal lowlands to triple-canopy jungle on steep mountain slopes / The AMERICAL Division battled the strong enemy influence in both Quang Nam and Quang Tri Provinces 11 Nov 67 - 11 Nov 68 in Operation WHEELER/WALLOWA with two of its brigades / Another brigade was sent to Quang Ngai Province in early 1968 / During 1969 and 1970 the division continued to fight in the Duc Pho, Chuy Lai and Tam Ky areas along the coast / In November 1971 the division was deactivated / The 23rd Infantry Division (AMERICAL) served a total of 1,526 days in Vietnam
