The 106th Infantry was activated on 15 March 1943 at Fort Jackson, South Carolina / In the Ardennes-Alsace Campaign, the Germans attacked the 106th on 16 December 1944 / The division's 422nd and 423rd Infantry Regiments were encircled and cut off by a junction of enemy forces in the vicinity of Schönberg / They regrouped for a counterattack, but were blocked by the enemy / The two regiments surrendered on 19 December / The Germans gained 6,000 prisoners in one of the largest mass surrenders in American military history / Nearly 50% of the division's strength was brushed aside in the first days of the Battle of the Bulge / The remnants of the division were reinforced by the 112th Infantry Regiment of the 28th Infantry Division and withdrew over the Our River and joined other units at Saint Vith / The division was never officially added to the troop list following the war

The Combat Infantryman Badge is awarded to infantrymen and Special Forces Soldiers in the rank of Colonel and below, who personally fought in active ground combat while assigned as members of an infantry, Ranger or Special Forces unit, of brigade size or smaller, any time after 6 December 1941

The Army of Occupation Medal was a military award of the United States military which was established by the United States War Department on 5 April 1946 / The medal was created in the aftermath of the Second World War to recognize those who had performed occupation service in Germany, Italy, Austria, or Japan / The original Army of Occupation Medal was intended only for members of the United States Army, but was expanded in 1948 to encompass the United States Air Force shortly after that service's creation / The Navy and Marine equivalent of the Army of Occupation Medal is the Navy Occupation Service Medal

Laredo Army Air Field (Laredo, Texas) - Opened on 23 September 1942 as Laredo Army Airfield, cadets were taught aerial gunnery for B-17 Flying Fortress and B-24 Liberator duty, training on the .50 and .30 caliber Browning machine guns / In December 1973, Laredo AFB was closed and turned over to the City of Laredo / Today the facility is known as Laredo International Airport.

**Miscellaneous:**

The 494th Bombardment Group, or "Kelly's Cobras", was the last B-24 Liberator bombardment group to be dispatched from the United States during the Second World War / The 494th was allocated to the Seventh Air Force, fighting in the Pacific / Towards the end of 1944 the group moved to Angaur, officially arriving on 30 September 1944, although the last members of the group did not reach the island until December / The group entered combat with a series of attacks on Japanese held islands in the Palau group, and the first of a long series of attacks on the Philippines / The Philippines became the group's main target during its first six months in the Pacific / The group carried out a large number of attacks on targets on Luzon, as well as taking part in the bombardment of Corregidor, and carrying out a series of raids over Mindanao / On 24 June 1945 the group moved to Okinawa / Forty-eight aircraft from the 494th became the first B-24 Liberator bombers to attack the

Japanese home islands from Okinawa / Their targets were Japanese airfields, starting with Omura Airfield and facilities around the Omura-Nagasaki area / During the last two months of the war the group attacked targets on the Japanese home islands and in Japanese occupied China / After the end of the war, the 494th was used to transport personnel and supplies into Tokyo and to liberate Allied prisoners of war being held in Japan

A bombardment group or bomb group was a group of bomber aircraft the United States Army Air Forces (USAAF) during World War II / It was the equivalent of an infantry regiment in the Army Ground Forces / A bombardment group was the key tactical control and administrative organization for bombers in all theaters of operation / U.S. bomb groups were numbered and classified into four types: Very Heavy (VH), Heavy (H), Medium (M), and Light (L) / Groups which combined bombers of differing categories into a single administrative organization were designated "Composite" groups

The Consolidated B-24 Liberator is an American heavy bomber, designed by Consolidated Aircraft of San Diego, California / The B-24 was used extensively in World War II. It served in every branch of the American armed forces as well as several Allied air forces and navies / Along with the B-17, the B-24 was the mainstay of the US strategic bombing campaign in the Western European theater / Due to its range, it proved useful in bombing operations in the Pacific, including the bombing of Japan / Long-range anti-submarine Liberators played an instrumental role in closing the Mid-Atlantic gap in the Battle of the Atlantic.

Robinson, located in North Little Rock, was originally established as Camp Pike in 1917, named for General Zebulon Montgomery Pike, famed U.S. Army officer and explorer, who was killed in action 27 Apr 1813, during the War of 1812 / Renamed for U.S. Senator Joseph Taylor Robinson of Arkansas in 1937 / With the start of World War II, the post took on a new role as a replacement training center / Initially, there were two centers, one for basic training and the other for medics / In 1944, the two were combined into the Infantry Replacement Training Center (IRTC) / In addition to its role in training soldiers, Camp Robinson also housed a large German prisoner of war facility, with a capacity of 4,000 prisoners

Sampson, from Palmyra, NY, a hero of the Battle of Santiago during the Spanish-American War

**Service Notes:**

Gunners Mate First-Class Raymond J. Ast, Jr. honorably served in the United States Navy / GM1C Raymond Ast was assigned to the Pacific Theater and earned 3 Battle Stars for combat action during the war in the Pacific

**Base Assignments:**

Sampson, New York - In the three-and-a-half years of its operation during World War II, the Sampson Naval Training Station trained 411,429 naval recruits before closing in 1946 / The camp was named in honor of a local Seneca County native, Rear Admiral William T. Sampson, from Palmyra, NY, a hero of the Battle of Santiago during the Spanish-American War

Newport, Rhode Island - The U.S. Naval Base at Newport served as a PT-Boat (Patrol Torpedo) training center, a torpedo training school, gunnery school and a Naval Air Training Center

Solomons Islands, Maryland - During World War II, the island was chosen by the Allied command as the site for training amphibious invasion forces. The lessons learned at Solomons proved invaluable on D-Day, at Tarawa, Guadalcanal, and in numerous other military operations / The Solomons was the site for the Naval Mine Warfare Test Station, Naval Amphibious Training Base, Mine Warfare Experimental Station and the Naval Dispensary, Naval Amphibious Training Base

St. Andrews Bay (Panama City, Florida) - Panama City became an important port, and was used for building ships (and later dismantling them) during World War II

Pensacola Naval Air Station (Pensacola, Florida) - Air Station was the primary training base for all Navy, Marine and Coast Guard aviators and Naval Flight Officers during World War II / Naval aviators from Pensacola NAS were

called upon to train the Doolittle Raiders at Eglin Field in 1942 in carrier take-offs in their B-25 Mitchell bombers

## *Miscellaneous:*

Raymond J. Ast, Jr. passed away on 31 March 1974 at the age of 81 years old and is interred at Nativity Cemetery, Orchard Park, New York

A Gunner's Mate took charge of gun and crew / Assembled and fired all types of guns / Handled ammunition, mines and depth charges.

Naval Training Centers introduced recruits to "boot camp" training and indoctrination / The recruits were given a battery of tests to determine their educational and skill levels, then trained in indoctrination, ordnance and gunnery, seamanship, fire fighting, physical training, military drill and shipboard duties

LST-573 was commissioned on 21 June 1944 / Assigned to the Asiatic-Pacific Theater / Participated in the Leyte, Mindoro and Philippines Landings / Decommissioned on 24 January 1946

USS LST-572 was commissioned on 19 June 1944 and assigned to the Europe-Africa-Middle East Theater (convoy HXM 301) and later reassigned to the Asiatic-Pacific Theater / LST-572 participated in the assault and occupation of Okinawa in June 1945 / USS LST-572 earned one battle stars for World War II service / The USS LST-572 was decommissioned on 8 March 1946

The Asiatic-Pacific Campaign Ribbon (Medal) was a military award to any member of the United States Military who served in the Pacific Theater from 1941 to 1945

Battle (Combat) Stars were presented to military personnel who were engaged in specific battles in combat under circumstances involving grave danger of death or serious bodily injury from enemy action

The American Campaign Medal/Ribbon (also known as the (ATO) American Theater of Operations Ribbon) was a military award of the United States Armed Forces which was first created on November 6, 1942 by President Franklin D. Roosevelt / The ribbon was intended to recognize those military service members who had performed military duty in the American Theater of Operations during World War II / The requirements for the American Campaign Ribbon were for service within the American Theater between 7 December 1941 and 2 March 1946 / The American Campaign Medal was issued as a service ribbon only for the entirety of the Second World War, and was only made a full-sized medal in 1947

The Philippine Liberation Medal was a military award of the Republic of the Philippines presented to any service member, of both Philippine Commonwealth and allied militaries, who participated in the liberation of the Philippine Islands between the dates of 17 October 1944 and 2 September 1945 / The Philippine Liberation Medal is intended to recognize military service in the last days of World War II when the military of Japan was driven from the Philippines and then to eventually surrender in September 1945 / To be awarded the medal, a service member must have served in the Philippines for at least thirty days during the eligible time period

Roosevelt / The medal was intended to recognize those military service members who had performed military duty in the European Theater (to include North Africa and the Middle East) and was awarded for any service performed between 7 December 1941 and 2 March 1946 / The European-African-Middle Eastern Campaign Medal was awarded as a service ribbon throughout the entire Second World War
